**1.2.** Din l-informazzjoni tingabar u tintuża skont il-Politika tal-Privatezza u l-Politika dwar il-Protezzjoni tad-Data tal-Kunsill Malti għall-Arti, u l-Politika tal-Privatezza tal-Gvern ta' Malta.

**1.3.** L-ospitant jista' jiffilmja u/jew jieħu ritratti tal-avvenimenti għall-istruzzjoni dirett online jew biex jergħu jintużaw b'mod diġitali (eż. fuq il-websajt tagħna; il-Midja Soċjali; jew format stampat). Dan se jkun bil-għan li jiġu promossi s-servizzi u jiġu pprovduti riżorsi. L-ospitant iżomm id-drittijiet tal-awtur u kwalunkwe proprjetà intellettwali oħra f'ritratti meħuda u/jew f'registrazzjonijiet diġitalizzati li jappartjenu lill-ospitant.

### 2. General Terms & Conditions

**2.1.** Participation implies the automatic acceptance of the venue's house rules.

**2.2.** Patrons must be in possession of a valid ticket at all times that must be handed over for inspection by the Entity staff when requested.
